**Sec. 1.400 Fee Exemption for Animal Rescuers**

Animal Rescuers as defined in Chapter 3 of the Big Spring Code of Ordinances shall be exempt from payment of the following permit fees:

- Animal License Fee (altered and unaltered)
- Redemption Fee - First Incident (altered and unaltered)
- Boarding Fee
- Adoption Fee
- Microchipping Fee

This shall not exempt such persons or entities from compliance with other applicable permit requirements.

## **APPENDIX A – BIG SPRING CITY CODE**

### **COLLECTION FEES – ARTICLE 2**

To the extent allowed by law, the City will assess a collection fee of Thirty Percent (30%) of the total amount of the account balance for receivable accounts that are not paid within sixty (60) days of the due date and that are to be referred to the contracted collection agency. The assessed collection fees will be used to compensate the outside agency for their efforts and expenses in collecting and processing the past due accounts. Once an account has been referred to the contracted collection agency, the total amount owed and the collection fee will be collected from the debtor regardless of whether the debtor pays the outside agency or pays the City directly.
