This zone is designed to provide locations for retail development to serve local neighborhood shopping, community shopping and regional shopping needs.

## Specific Use Permits

A specific use permit **without term** may be issued in the Retail District (R) through final approval by the Planning and Zoning Commission subject to, but not limited to specified restrictions as follows:

Accessory building for living or sleeping quarters not including rental as a separate dwelling · Airport landing field or heliport · Bed and breakfast · Bingo Hall · Cemetery or mausoleum · Fairground or exhibit area · Mini storage warehouse (consisting of private storage rental units, each unit not to exceed 3100 cubic feet in size and not larger than 24 feet by 10 feet in area) · Mobile home park or manufactured home park or travel trailer or recreational vehicle park and containing no less than 5 acres and subject to all of the special requirements, conditions or safeguards that may be imposed by the Council and incorporated in the permit. The minimum area for each mobile home or manufactured home dwelling unit shall be 4,000 square feet · Outdoor theater · Pet shop · Petroleum or gas · Petroleum collecting or storage · Wireless communication towers

A specific use permit **with term** may be issued in the Retail District (R) through final approval by the Planning and Zoning Commission subject to, but not limited to specified restrictions as follows:

Dance hall or night club · Group secure care home for persons for which supervision or security is required to ensure that they do not leave the facility, or because the residents are considered dangerous to themselves or others, except for prisons or correctional facilities
